Commissioner eyes infrastructure as a way to increase growth

When William "Bill" McDaniel was first elected as Collier County Commissioner in 2016, he sought to change how Collier County spent taxpayer money.

One of the first items on the chopping block was cutting a portion of the \$5 million Collier County was using for improvements to median landscaping.

Throughout his first term, Commissioner McDaniel worked to help bring

change to District 5 which encompasses the Immokalee area. McDaniel pointed out that he spent his first term emphasizing needed improvements to Lake Trafford Memorial Gardens

to Lake Trafford Memorial Gardens to help alleviate flooding of the cemetery grounds and completing and passing the Immokalee Area Master Plan.

Now that he is in his second term, McDaniel said that three areas concerning him most are public safety funding, infrastructure

Can students really make snow storms? In a jar, sure! How about magic crystals?



improvements and improvements that help promote a better quality of life for area

McDaniel pointed to several infrastructure changes on the horizon for Immokalee that would allow for increased import and exports of local goods. Expansion of the Immokalee Regional Airport is just one improvement that McDaniel sees as necessary.

Currently, runway 9-27 sits at just 5,000 feet long. McDaniel said that the upcoming expansion will increase that to 7,500 feet with room to eventually increase the runway to 10,000 feet.

'We finally have a Master Plan that matches the needs of the Airport Master Plan and for the first time those two plans are in sync," McDaniel said.

"With the added runway length comes jobs," McDaniel said. For starters, Immokalee Regional Airport is now home to at least one flight school and all of the

existing hangers are currently occupied. "As it stands, there is currently a waiting list for a tenant to occupy a hanger. It costs approximately \$1 million to build each new hanger. I would like to see the county build additional hangers, lease them for a period of time and then sell them," McDaniel said.

Beyond increased anticipated air traffic and jobs associated with it, McDaniel pointed out that local roads will also see a much needed improvement. What was once a plan to build a new toll road from Lakeland to Alligator Alley, the plan has now changed to improve existing roadways instead.

McDaniel cited the recent completion of the Multi-use Corridors of Regional Economic Significance (M-CORES) report. According to McDaniel, one option the taskforce is now looking at is widening State Road 29 on both ends of Immokalee and adding a toll to generate funds to pay for the project. Widening the existing roadway would minimize impact on the natural environment and would be less of an impact to local wildlife.

Immokalee is still slated to see a bypass that will connect State Road 29 to the south of the Immokalee Regional Airport to the northern end of State Road 29 north of New Market Road

One concern that many have is the increased development of communities in eastern Collier County and the destruction of natural habitat that comes with it. McDaniel recognized this concern. "We need to protect agricultural land around Immokalee by providing credits to landowners to keep those properties available for farming," McDaniel said.

Impact fees are another topic that Commissioner McDaniel is concerned about. With the average new home costing the homebuyer approximately \$30,000 in impact fees, first time home buyers may be priced out of the local market. In recent years, McDaniel has proposed a pilot program for Immokalee where residents could finance their impact fees over a period of time rather than paying those fees up front. Previously that measure didn't gain traction but McDaniel plans to bring it up again when the County Commissioners meet to hire a new county manager.

When it comes to healthcare and

improving access to care, McDaniel said "Immokalee doesn't have the population to support a hospital yet. We need close to 150,000 residents in this part of the county before we can expect a hospital in this area." McDaniel didn't rule out the possibility of private-sector urgent care facilities coming to the area with the growth that is taking place in Ave Maria.

McDaniel said although this election has been challenging for many, we may see a push for nationwide standards when it comes to national elections.

'I'm not opposed to same-day registration [to vote], but we need to end it across the nation on the same day. If your state allows mail-in ballots, then we need to implement a very good system that's designed to track those ballots," McDaniel said. Mc-Daniel also said that we need to develop a national standard for how long states have to accept mail-in ballots.

McDaniel said that regardless of the outcome, there will still be challenges that we will face at the local level that leaders will have to face including job growth, education, and improving health care.



DOH-Collier encourages a healthy holiday season

NAPLES — The Florida Department of Health in Collier County (DOH-Collier) encourages healthy holiday habits to help residents and visitors celebrate. The information below can help keep you, your family and your community safe.

Mask up against COVID-19. While celebrating this holiday season, remember COVID-19 is still in our community.

It is important to avoid the following:

- Visiting the homes of others or hosting gatherings with those not in your immediate household, unless you can wear a mask or cloth face covering and socially distance.
- Large gatherings; per the State Surgeon General's Public Health Advisory, avoid gatherings of 10 or larger.
- Sharing food, cups, forks, spoons, knives and serving utensils.
 - Crowded indoor events.
- Attending crowded parades, runs, or other events.

Ways to celebrate at home include:

- Have a small celebratory dinner with only the people who live in your household.
- Have a virtual dinner and share recipes with friends and family.
 - Shop online rather than in person.
- Watch sports events, parades, and movies from home.

Fires, falls and food safety should be a priority year-round, but even more so during the busy holiday season. In fact, according to the U.S. Fire Administration (USFA FEMA), the top three days of the year for home candle fires are Christmas, New Year's Eve and New Year's Day; and more than one-third of home decoration fires are caused by a candle. When decorating for the holiday season, it is important to make safety a priority.

Candle safety — Help avoid fires in your house by keeping all candles away from children, pets, trees and curtains. Candles should be at least 12 inches away from anything that burns.

Fire safety— The Centers for Disease Control and Prevention (CDC) recommends testing your smoke detectors and carbon monoxide detectors in your home once a month and replace the batteries twice a year.

Tree safety — If you have a real tree in your house this season, keep it watered. A tree that is not well watered is very dangerous and can turn into a fire hazard. It is best to water the tree every day and dispose of the tree after the holidays or when it is dry.

Decoration safety — Use step stools or ladders while putting up decorations. Never stand on furniture; this can result in an injury.

Shoe safety— When putting up holiday lights and other decorations, make sure to wear protective and sturdy shoes inside or outside of the house. No flip-flops!

Oven safety — Always use an oven mitt while taking food out or putting food into the oven.

Kitchen safety — While in the kitchen, be sure to remove any scarves, long necklaces or flowy clothing. These items can be a hazard while cooking and baking.

Food safety — Before and after handling raw meat, poultry, eggs and seafood make sure to wash your hands with soap and water for 20 seconds. Cook all foods to the proper temperature by using a food thermometer. If you do not have one, purchase one! Baking holiday sweets might come with the temptation of eating the dough or batter, but that is not safe. Make sure to refrigerate perishable food within two hours. If the temperature is above 90 degrees Fahrenheit, chill food within 1 hour.

Brighten your holiday season by making health and safety a priority with these healthy holiday habits!

Mascarilla Contra COVID-19. Mientras celebre esta temporada, recuerde que el COVID-19 aún sigue vigente en nuestra comunidad.

Es importante evitar lo siguiente:

- Visitar otros hogares, o albergar reuniones invitando personas con quienes no convive, a menos que lleve puesto una mascarilla facial y mantenga distancia social.
- Multitud; el Cirujano General Estatal de Salud Publica, advierte evitar asisitir a reuniones con más de diez personas.
- Compartir comida, vasos, tenedores, cucharas, cuchillos, y utencilios de servir.
- Actividades dentro un salón que sean conglomeradas.
 Asietir a desfilos carreras y otros
- Asistir a desfiles, carreras, u otros eventos de multitud.

Recomendaciones para festejar en casa:

- Celebración pequeña con solo aquellos que conviven en su hogar.
- Cena virtual para compartir con sus demás fmiliares y amistades.
- Comprar en línea por internet y no en persona.
- Mirar eventos deportivos, desfiles, y películas desde su hogar.

Incendios, caídas, y seguridad alimenticia deben ser una prioridad durante todo el año, pero más aún, durante las tepora-

das festivas. De hecho, de acuerdo con la Administración de Fuegos de los Estados Unidos (USFA FEMA), los tres días del año que más reportan fuegos provocados por velas son: Navidad, 31 de Diciembre y Año Nuevo. Más de un tercio de los fuegos decorativos son causados por velas. Entonces, al decorar, es importante priorizar la seguridad.

Hábitos de Seguridad y Velas – Evite incendios en su casa, manteniendo todas las velas fuera del alcance de niños, mascotas, plantas, árboles y cortinas. Las velas deben colocarse por lo menos a una distancia de doce pulgadas de lejanía a cualquier objeto que pueda incendiarse.

Hábitos de Seguridad e Incendios – El Centro de Control de Enfermedades (CDC), recomienda examinar los detectores de humo y de monóxido de carbono en su hogar una vez al mes, al igual que remplazar sus baterias dos veces al año.

Hábitos de Seguridad y Arboles – Si usted tiene un árbol real en su casa durante esta época festiva, mantengalo hidratado. Un árbol que no está bien hidratado es muy peligroso y puede

convertirse en un objeto de riesgo de incendio. Es major hidratarlo todos los días y deshacerse de él después que terminen las fiestas o cuando se seque.

Hábitos de Seguridad y Decoración – Emplee un peldaño o una escalera para colocar su decoración. Nunca se pare sobre un mueble, esto puede resultar en una lesión.

Hábitos de Seguridad y Calzado – Al

instalar sus luces decorativas, asegurece de calzar zapatos protectores y fuertes dentro y fuera de la vivienda. No vista calizos.

Hábitos de Seguridad y Hornos – Siempre utilice un guante de hornos al colocar alimentos dentro del horno. Igual al sacarlos.


Hábitos de Seguridad y Cocina – Mientras este en la cocina cerciorese de remover cualquier bufanda, collar largo o ropa suelta. Estos objetos pueden ser un peligro al cocinar y hornear.

Hábitos de Seguridad y Alimentos – Antes de tocar carnes crudas, mariscos y huevos, asegurece de lavarse las manos con agua y jabón por veinte segundos. Cocine los alimentos a la temperatura justa usando un termómetro de cocina. Si no tiene uno, compre uno! Hornear los dulces festivos puede tentarlo a comer la masa o la mezcla, sin cocinar, pero eso no es prudente. Cersiorese de refrigerar los alimentos perecederos a más tardar dos horas.
